NOTICE

Due to spread of COVID-19 pandemic and continuous Lock-Down, along with others, the following important issues are pending under the University:

- i. Certain Examinations were held up midway and a number of Examinations planned to be held during March, 2020 onwards as per the Examination Calendar for 2020, the Examination Schedules could not yet be drawn up.
- ii. Re-evaluation/Review of Answer Scripts of some Examinations including MBBS 3rd Prof Part-II are pending.

Considering the current situation and related aspects, the followings are hereby notified for information of all concerned (including the Students concerned):

1. Holding of University Examinations -

The Authority of the University is considering the following Planning for holding the University Examinations:

- i. Examinations of which both the Theory and Practical Examinations held up (either partially or fully) [e.g., Post-Graduate Degree in Modern Medicine/Dental Sciences etc.]:
 - a) Theory Examination may start not before 15 (fifteen) days after lifting the present ban of train/bus services (either partial or fully) by the Government.
 - b) Practical Examination may start not before 10 (ten) days after the end of the Theory Examination.
- Examinations of which the Theory Examination was completed but the Practical Examinations have been held up (either partially or fully) [e.g., BHMS 3rd Prof (New & Old Regulations) etc.]:

Practical Examination may start not before 15 (fifteen) days after lifting the present ban of train/bus services (either partial or fully) by the Government.

iii. Examinations planned to be held during March, 2020 onwards as per the Examination Calendar 2020 but could not yet be scheduled:

Same principle as at sub-para (i) above may be followed.

2. Re-evaluation/Review of Answer Scripts of some Examinations

- i. The entire process of Review is manually done. After introducing the system of 'Codification' and 'Randomisation' of Answer Scripts before evaluation and review of each paper by 2(two) Examiners, the process has become more complicated and longer time-consuming. Due to continuous Lock-Down after receipt of application for Review of Answer Scripts of MBBS 3rd Prof Part II Examination, the process could not start. In spite of the best efforts, publication of results of Review would take a reasonable time (say, 3 weeks) after starting normal office.
- ii. The Supplementary Examination would be held quickly (say, within 2 weeks) after publication of Review Results.
