NOTICE

Sub: Validity of Marksheet of Post Basic B.Sc. Nursing Part-I Examination, 2014 held in the month of July, 2014.

It is hereby notified for all concerned that:

- 1. As per the guidelines of Indian Nursing Council, the marks of subsidiary subjects are shown in the Marksheet but are not included in the 'Grand Total'.
- 2. From the old records of the University, the following information could be extracted
 - i. the results of Post Basic B.Sc. Nursing Part-I Examination, 2014 held in the month of July, 2014 was published on 6th December, 2014 and the marksheet was issued in December, 2014 the first print out was taken on 11.12.2014,
 - ii. subsequently, on detection of errors of inclusion of the marks of subsidiary subject (English) in the Grand Total of the marksheet, Revised Marksheet was printed on 22.12.2014 correcting the error,
 - iii. as per usual practice, all the colleges were supposed to return the original marksheets (if taken delivery from University) to the University and take the Revised Marksheet and issue to the concerned candidates.
- 3. For the aforesaid examination, the 'Revised Marksheet' is the 'Correct and Valid' marksheet and the earlier marksheet (without the word 'Revised') is 'Invalid'.
- 4. Recently it has been brought to the notice of the University that the incorrect marksheets are lying with some of the candidates the fact of issuance of the 'Revised Marksheet' to each and every candidate of the said examination could not be verified due to non-availability of the old records.
- 5. Now, it is hereby further notified that -
 - All the candidates of the aforesaid examination are hereby directed to verify the marksheet of the above examination in their possession whether it is valid i.e. the 'Revised Marksheet'. If not, they are further directed to collect the 'Revised Marksheet' from their respective colleges surrendering the invalid marksheet. If any candidate of the aforesaid examination has taken any benefit in whatsoever manner on the basis of the 'Invalid Marksheet', she is directed to bring the fact into the knowledge of the Appropriate Authority for taking corrective steps.
 - ii. All the concerned Nursing Colleges are requested to verify their records, immediately surrender the invalid marksheet, if any, lying with them and/or with any student of their colleges to the University.
 - iii. All other Organisations/Offices including the colleges imparting M.Sc. Nursing Course are requested to verify and see whether any candidate of the aforesaid examination has used the invalid marksheet for any purpose in their Organisations/Offices/Colleges and if so, appropriate steps may be taken. \(\)
