Notice for centralized and decentralized manual mop up WB JENPAS UG 2021 counseling (Excluding nursing courses)

In view of few seats remaining vacant in West Bengal JENPAS UG 2021 counseling (excluding the nursing courses) as conducted by the WBJEEB, it is hereby decided to undertake a round of centralized manual mop up with the eligible candidate list as received from WBJEEB who have appeared in JENPAS UG 2021 exam along with 10+2 eligibility, have registered for counseling with WBJEEB but were not allotted any seat in that counseling as per merit and choice.

Such counseling shall be conducted as per the General Merit Rank (GMR) as provided by the WBJEEB to the applicants.

The counseling shall be manual that is the willing and provisional eligible non allotted listed candidate has to attend the centralized manual mop up counseling venue with original testimonials [Rank card of JENPAS UG 2021, valid photo ID card, 10+ 2 mark sheet and "opt in "certificate generated from website of WBUHS] and have to appear for choosing the vacant seat at his/her rank and caste at the counseling venue. The eligible candidates shall be called as per the Common GMR as stated earlier. No counseling fees will be charged from these candidates.

The candidates whose names appear in the provisional eligible non allotted candidate list as provided by the WBJEEB shall be eligible to appear for such counseling only if they are still not allotted to any course through WB JENPAS UG 2021 counseling conducted by the WBJEEB earlier or the Mop Up Nursing counseling. They have to sign an undertaking in this regard before allotment.

The conversion of seats (if seats remain vacant and the eligible candidates desirous of getting allotted to such seats are not found in such counseling) shall be as per the given rule after one complete rotation of the counseling process:- PC seats to respective category (non PC) SC to ST and vice versa OBCA to OBCB and vice versa EWS to UR (Unreserved)

Such conversion shall be for one single rotation one after another in this sequence and the candidates eligible and willing to participate shall be called as per Common GMR for allotment for every such rotation till either the last seat is filled up or the last eligible and willing candidate is called for allotment.

The candidates who are eligible and already applied for JENPAS UG 2021 counseling to WBJEEB successfully, have to log in to the website of The WBUHS and have to provide personal credentials like Application number, date of birth and Name (exactly in the same spelling applied for in WBJEEB portal for JENPAS UG 2021 counseling earlier). Thereafter they shall be guided to "**opt in**" menu where if they want to participate in such mop up counseling, have to click **opt in** and take print out of such.

The candidates once allotted a seat in the said mop up counseling shall not be able to modify it later on. They have to take admission at the allotted college within stipulated date/s after verification of the original documents and payment of college fee as applicable. If the allotted candidate fails to get himself/herself admitted within stipulated time, then the allotted seat shall be cancelled and the candidate shall be out of the counseling process.

The candidates who opt in for such manual counseling, have to report to the counseling venue as per time slot provided with the original documents without which the candidate shall not be allowed to participate in the said counseling process.

After the allotment of the seat, the candidate shall be handed over the allotment letter authenticated by the WBUHS officials. The candidate has to report to the allotted college within stipulated time with the allotment letter, original documents (age proof, class 12 mark sheet, print out of candidate profile downloaded from WBJEEB for JENPAS UG 2021 counseling containing the GMR, valid photo ID card, opt in certificate generated from website of WBUHS, caste certificate as applicable and Person with Disability certificate if applicable) and college fee. If the candidate fails in the document verification then the said seat shall be cancelled and the candidate shall be out of the counseling process.

In view of the recent letter <u>17-852/B.A.S.L.P./2021/RCI</u> received from Rehabilitation Council of India (RCI) the following institute namely <u>Pratibandhi Kalyan Kendra, Hoogly</u> is hereby barred from taking admission of students for the current academic year in BASLP course. Hence, on humanitarian ground the already admitted candidates in the said course in the said college are hereby also allowed to take part in the said mop up counseling following all above norms if they wish so. The vacant seats of such course in such college shall not be included in the seat matrix for centralized manual mop up counseling conducted by the WBUHS.

If after conduction of such centralized manual mop up counseling, seats are still lying vacant then a college level decentralized manual mop up shall be arranged where upto 25% of the total seats shall be allowed to be filled up by the concerned colleges, from the candidates who have qualified 10+2 as per merit even if they have not appeared for JENPAS UG 2021 exam.

In order to allow such candidates who have not appeared for JENPAS UG 2021 exam but have qualified 10+2 and are eligible for such courses, or any remaining candidates who are otherwise eligible through 10+2 result and had appeared in JENPAS UG 2021 exam but not registered earlier for counseling conducted by WBJEEB or nursing counseling, registration may be allowed before such college level mop up.

Such candidates desirous of appearing in such decentralized mop up have to log into the website of WBUHS and have to fill up the application form online (based on whether they have appeared in JENPAS UG 2021 or not) and they have to pay counseling fee of Rs 3000/- (three thousand only) via online payment mode (bank charges as applicable to be provided extra). SC/ST/OBC/EWS/PwD candidates can pay counseling fee of Rs 2000/- (two thousand only) instead via online payment system (bank charges as applicable to be provided extra).

After successful payment such candidates shall be able to generate the registration receipt. The candidates who appeared for JENPAS UG 2021 exam shall be arranged as per GMR provided by the WBJEEB.

The candidates who have not appeared for JENPAS UG 2021 exam but have successfully cleared 10+2 exam and are otherwise Page 3 of 4

eligible for such courses, have to provide marks information about 10+2 exam for ranking and tie breaking purpose. They have to be listed separately as per total marks obtained in the 10+2 exam and the tie breaking shall consider in the following order of marks in Biology, Marks in Chemistry, Marks in Physics and finally age (higher age shall be provided higher merit rank).

The college level mop up shall be conducted on a fixed date initially with JENPAS UG 2021 appeared candidates based on merit. They have to appear personally before the concerned college (any one with vacancy) on the given date before the scheduled cut off time with the required original credentials as stated above and college fee.

The concerned college authority shall admit such candidates as per General Merit rank in the vacant seats. No further conversion is allowed in this decentralized college level mop up counseling. The vacant reserved seats shall have to be filled up by the particular reserved category candidates only.

If any seat still remains vacant after the above stated procedure, then upto 25% of the total seats shall be allowed to be filled up by the concerned colleges from the candidates who have qualified 10+2 as per merit even if they have not appeared for JENPAS UG 2021 exam who have registered newly for appearing in college level mop up as stated above on another fixed date and time.

This may be allowed in view of covid 19 situation for the present academic year i.e. 2021-22.

The details of the counseling venue, date, time slot of appearance at the counseling venue, vacancy status and admission date schedule etc shall be uploaded in the website of The WBUHS (www.wbuhs.ac.in) in due course. The eligible and willing candidates are hereby requested to frequently visit the website for updates since no personal communication is entertained.

If any candidate is found later to have applied unscrupulous means or provided forged/fabricated documents for allotment and admission, their candidature shall be rejected at once and such seat shall remain vacant.
