Suggested modification of objective- 1: - To estimate the proportion of infants aged less than six months having underweight in a rural community of Rampurhat Health District of West Bengal. b. One of the research questions of the study is – "What is the proportion of underweight among infants aged less than six months"? And - expected outcome of the study is- "Reduction of growth faltering among infants aged less than 6 months" (in the intervention block). So, Objective No. 1 of the study should be suitably modified to include - estimation of baseline and end-intervention proportion of infants (< six months) having underweight in both the blocks. Methodology / work-plan/ timelines should be duly modified. c. Sample size was calculated based on 10% reduction of malnutrition among under 6 months children in 1 year. Examiners thought that 10% reduction might not be feasible in such short period and suggested detailed justification/ appropriate reference/ suitable modification for that. Expert comments advised need to justify 10% reduction of Malnutrition as a yard stick. d. Proposed that - the eligible pregnant women will be recruited during their EDD ± 7 days. But, examiners suggested that newborns should be recruited within +/- 7 days of delivery. e. Validated tools are available to assess maternal mental health status – examiners suggested using them with suitable modifications. 			f. The proposed two days training of ANMs is better to be arranged in Rampurhat MC considering the cost, but it can be organized in COM & Sagar Datta hospital if funding is ensured g. Regarding funding support for different activities including involvement of ASHAs - the investigator has informed that- The State Resource Centre on Nutrition (SRCN) will be approached to support the training activities. The visits/ contacts made by the ASHAs will be those mentioned in different programs (HBNC, HBYC, MAA program) which are already incentivized (page -18/lines-6-10 of revised proposal). h. Reduction of under-nutrition among children is a national priority and there is paucity of such type of intervention cum implementation research studies in this field, so the proposal may be accepted after the suggested modifications. i. AWW should be included as stakeholders. j. As Postnatal/Pediatric wards are not be available in CHC?RH, it is to be done in District Hospital/Medical College k. Sampling method, plan for analysis needs more elucidation.
