### TERMS AND CONDITIONS:

1. The appointment is made against a permanent vacancy. The appointment is done purely on full time regular basis, likely to be confirmed on satisfactory completion of the period of probation. However, the appointee shall be on probation ordinarily for a period of one year from the date of appointment and such period of probation may, at the discretion of the appropriate authority of the University, be extended for a further period not exceeding one year. If, at any time during the period of probation, the probationer's work is not considered satisfactory, the probationer shall be discharged by the Authority concerned.
2. The Pay of Teaching Faculty upon appointment as **Assistant Professor** shall be fixed in the revised level of **18** as per Revised level of WBS (ROPA) Rules, 2019 [HF/O/MERT/688/HFW-24099/9/2020 dated 23<sup>rd</sup> July, 2021]. The teaching faculty will also be entitled to get (a) NPA @ 24% of revised basic pay subject to maximum Rs. 24,000/-, further subject to the condition that basic pay and NPA shall not exceed Rs. 2,01,000/- p.m. and (b) HRA @ 12% of revised basic pay subject to maximum Rs. 12,000/- p.m.
3. The payment of salary of the appointee will be subjected to the deduction of Income Tax and Tax on Profession payable on the income of their salary.
4. The appointee has to submit a written undertaking at the time of joining that (a) he/she is not in any other service/job in any other Institution on the date of joining COM & JNMH, Kalyani; (b) that there is no criminal case or civil suit pending against him/her in any court of law in India.
5. The appointee will conform to all rules and regulations whether existing or amended or extended from time to time in the West Bengal University of Health Sciences and shall carry out all other

The University reserves the right to terminate his/her service at any time without assigning any reason thereof with three months' notice or salary in lieu of as per Rules and Regulations of the West Bengal University of Health Sciences. Resignation from the said post will be guided by the Statutes, Rules and Regulations of the West Bengal University of Health Sciences.
7. At the time of joining the appointee has to submit self-attested photocopies of the following which the Principal of the College shall verify before allowing him/her to join:

Medical College & Hospital (x) Original documents pertaining to Reservation Categories (wherever applicable).

8. The appointment is deemed to have been made on the clear understanding that the appointee has accepted the terms and conditions without any reservation.
